



A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, January 10, 2022 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct. 2-Charles Morris, Pct. 3-Ted Brannon and Pct. 1 Commissioner Jeff Williams. Pct 4-Jerry Benham was not present.

County officials present: LuAnne Terry, Treasurer; Terri Laurence, District and County Clerk and Ted Weems, County Attorney.

Also present: Carol Williams, Administrative Assistant; Michael Isbel, Emergency Management Coordinator; Danya Peterson, AgriLife Extension, Kim Wilks, Royce Hart, Curt Greer and Julia Childs, Post Dispatch.

Judge Norman called the regular meeting to order at 9:01 a.m.

Order 1: Prayer

Order 3: Public Comment
None presented.

Order 4: Minutes from the December 28, 2021 regular meeting were approved as presented with a motion by Commissioner Williams and seconded by Commissioner Brannon. With a majority of the court members voting aye, the motion carried and so ordered.

Order 5: Came on for consideration was accounts payable for December 28, 2021 through January 10, 2022.
Motion was made by Commissioner Brannon and seconded by Commissioner Morris that all accounts presented are ordered paid and presented to the Treasurer for payment. With a majority of the court members voting aye, the motion carried and so ordered. (Attachment)
