Michael Isbell, Emergency Management Coordinator: Decided on a 600 gallon tank for use of the fires at Justiceburg. Continuing to work on Mitigation Grants. Strongly encourages the public to registrar for the 911 data. Registration is on the County and City Websites and there is no cost.

Judge Norman: Government grant has been approved. This grant will be used to help individuals train to work at the Dalby Unit. Received funds from the American Rescue Plan Act. Received email from Sheriff Terry Morgan stating they have visited with Dalby Unit helping them learn the jail standards.

Order 10: Budget Workshop.


Order 11: Budget Amendments and Line Item Transfers.


