



A Special meeting of the Commissioners' Court of Garza County, Texas was held on Thursday, September 15, 2022 beginning at 1:30 p.m. at the Commissioners' Courtroom, 300 W. Sheriff: Inmates in jail waiting for state beds have been moved to a State Jail Facility today. The inmates have spent 1370 days in the Garza County Jail which costs the county \$75,350.00. Motion was made by Commissioner Benham and seconded by Commissioner Brannon to accept the reports as presented. With a majority of the court members voting aye, the motion carried and so ordered.



- Order 6: Consider to approve Second Amended and Restated Operations and Management Services Agreement with MTC on the Dalby Facility. Still in discussion with MTC. Will be extending agreement for another week. A motion was made by Commissioner Williams and seconded by Commissioner Morris to extend the agreement.
