

A Regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, December 11, 2023 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct. 1-Jeff Williams; Pct. 2-Kim Wilks; Pct. 3- Ted Brannon and Pct. 4-Giles W. Dalby. Judge Norman called the Regular Meeting to order at 9:00 a.m.

Order 3: Public Comment None presented.

Order 4: Minutes from the November 27, 2023 regular meeting were approved as presented with a motion by Commissioner Williams and seconded by Commissioner Wilks. With a majority of the court members voting aye, the motion carried and so ordered.

Order 5: Came on for consideration was accounts payable from November 27, 2023 through December 11, 2023. Motion was made by Commissioner Dalby and seconded by Commissioner Brannon that all accounts presented in the fund requirement print-out is ordered paid and presented to the Treasurer for payment. Order 6: Reports from county offices-The following items of information were brought before the Court as a written and/or verbal report:

Chelsey Webb, Juvenile Probation Officer: County Attorney's Office has been helpful with files and rearranging in Juvenile Probation Office.

Judge Norman: Received a letter from TXDOT stating the county currently does not meet the categories to be considered an economically disadvantaged county. Directors for the Garza County Central Appraisal District Board have been chosen which are Cody Alford, Julia Childs, Royce Hart, Jeff Lott and Marvin Self.

Kim Wilks, Commissioner Pct. 2: Landfill was to be completed by December 6, 2023. Have stated they will be done by the end of December but do not think they will make completion by this time. Will wait until the end of December and if not completed, will make a decision whether to fine them for non-completion.

- Order 7: Consider to approve Jail Housing Contract from Gaines County. A motion was made by Commissioner Wilks and seconded by Commissioner Brannon to approve the contract. With a majority of the court members voting aye, the motion carried and so ordered. See attachment.
- Order 8: Consider to approve Joint Resolution and Statistical Information for Joint Primary. Kylene Wheeler explained that the Republican and Democratic parties plan to enter a contract to conduct their Primary Elections for March 5, 2023. A motion was made by Commissioner Dalby and seconded by Commissioner Wilks to approve the Joint Primary. With a majority of the court members voting aye, the motion carried and so ordered. - Order 9: Consider to approve Addendum to Current Conflict of Interest in Garza County Personnel Manuel. The addendum states an employee, Officer, or Elected Official of Garza County must disclose any potential conflict that is known by the employee, officer or Elected Official with respect to any contract or bid for the purchase of goods or services from a private vendor. A motion was made by Commissioner Brannon and seconded by Commissioner Williams to approve the addendum. With a majority of the court members voting aye, the motion carried and so ordered. - Order 10: Consider to approve 2024 Implementation of the County Assistance
 Program offered by TXDOT for Surplus Material. Transportation Code
 201.706 requires TXDOT to assist counties with materials to repair and
 maintain county roads damaged by the impact of 2060 Weight
 Tolerance permits. A motion was made by Commissioner Williams and
 seconded by Commissioner Wilks to approve the County Assistance
 Program offered by TXDOT. With a majority of the court members
 voting aye, the motion carried and so ordered. See attachment.
- Order 11: Consider to approve Tactical Rifle Resistant Armor Resolution Grant-#4847901. A motion was made by Commissioner Dalby and seconded by Commissioner Williams to approve the Grant. With a majority of the court members voting aye, the motion carried and so ordered.
- Order 12: Budget Amendments and Line Item Transfers. A motion was made by Commissioner Dalby and seconded by Commissioner Williams to approve the amendment to close Juvenile Probation Funds Account in the amount of \$1,447.23. These fees are not collected anymore. The \$1,447.23 will be deposited to Juvenile Probation Fund #14. With a majority of the court members voting aye, the motion carried and so ordered.
