

A Regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, March 11, 2024 beginning at 9:15 a.m. at the Commissioners' Courtroom, 300 W. Sheriff Morgan: Jail Inmate Count; 85, 31 are county inmates and 54 out of county. Garza County Billing and Calls for Service Report for February 2024. See attachment.

Kylene Wheeler, Elections Administrator: Had a good turn out in Primary Election. Partial re-count was done last Friday.

Michael Isbell, Emergency Management Coordinator: Went to the Panhandle to help with the wildfires for 4 days. There is no expense to the county. Expenses are reimbursed by the state.

Chelsey Webb, Juvenile Probation Officer: Will be in training on Monday, Tuesday and part of Wednesday.

Judge Norman: Sheriff Morgan done a good job supporting the Election. Zane Reiter, Family Health Community Agent is having a Car Seat Event on March 12, 2024 from 10:00 a.m. until noon. Will be having an increase in Health Insurance. Explained the more the county participates in the Wellness Programs that are offered will help lower the health care premium costs. A presentation for the Healthy County Program will be April 10, 2024 for county employees at the Sheriff's Department from 8:00 a.m. until 12:00 p.m. and will be at the Rotary Luncheon at the Community Center at 12:00 p.m. Child Welfare Board will be having a Rainbow Room. Will be accepting baby accessories, toiletries and etc. to those in need. These items will be located at the Sheriff's Department.
