Lee Norman - Garza County Judge

A regular meeting of the Commissioners' Court of Garza County, Texas was held on Monday, April 8, 2019 beginning at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners, Pct.1-Jeff Williams, Pct. 2-Charles Morris, Pct.3-Ted Brannon and Pct. 4-Jerry Benham.

County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; Terry Morgan, Sheriff; LuAnne Terry, Treasurer; and Nancy Wallace, Tax Assessor/Collector.

Also present: Billie Williams, Administrative Assistant; Brandy Fannon; and Julia Childs, Post Dispatch.

Judge Norman called the regular meeting to order at 9:00 a.m.

Order 1: Minutes from the March 25, 2019 regular meeting were approved as presented with a motion by Commissioner Benham and seconded by Commissioner Brannon. With a majority of the court members voting aye, the motion carried and so ordered.

Order 2: Reports from county offices - The following items of information were brought before the Court as a written and/or a verbal report:

- a. Sheriff Morgan: The jail has 85 inmates, 27 are Garza County inmates. The police radio generator is over 45 years old and needs replacing. The electric to the unit was brought up to code. Purchased seven new deep cycle batteries. There is now a service agreement to maintain the system. A new generator was ordered. The cost for all the work and supplies will be about \$6200. Also, the Sally Port door at the jail will be repaired soon.
- b. Treasurer Terry: TAC was in to review the health insurance claims and Garza County's are down from last year. New rates are due in June and there is hope that they will be lower.
- c. Judge Norman: Is communicating with legislators in Austin concerning county government issues.
- d. Treasurer

- f. Tax Assessor/Collector
- g. Justice of the Peace - Pct. 1
- h. Justice of the Peace - Pct. 2
- i. County Court Monthly - Office of Court Administration (March)

- l. Mental Health - Guardianship (DPS)

Motion was made by Commissioner Williams and seconded by Commissioner Benham to accept the reports as presented. With a majority of the court members voting aye, the motion carried and so ordered. (Written reports are attached.)

- Order 3: Came on for consideration was the precinct and countywide accounts payable for March 26, 2019 through April 8, 2019. Motion was made by Commissioner Morris and seconded by Commissioner Williams that all accounts presented in the fund requirement print-out is ordered paid and presented to the Treasurer for payment. With a majority of the court members voting aye, the motion carried and so ordered. (Printout is attached.)
- Order 4: Came on for consideration was a proclamation/resolution for Child Abuse Prevention Month. Motion was made by Commissioner Brannon and seconded by Commissioner Benham to proclaim April 2018 Child Abuse Prevention Month in Garza County. With a majority of the court members voting aye, the motion carried and so ordered. (Proclamation/Resolution is attached.)
- Order 5: Came on before the court was Brandy Fannon with a County Jail Billing report. Brandy Fannon distributed a letter describing her jury duty experience and requested that the court consider replacing the chairs in the courtroom. She reported the amount she has saved the County and suggested there should be enough savings to replace the chairs in the courtroom. NOTE: Judge Norman replied by referring to the State's efforts to limit counties from raising necessary revenues. No action necessary.
- Order 6: Came on for consideration was a Tax Deed for parts of lots 1 and 2, block 157 of the Original Town of Post, Garza County, Texas. The bid is from Rebecca and Juan Hernandez for \$100. Attorney Weems recommended approving the bid. Motion was made by Commissioner Benham seconded by Commissioner Williams to approve the tax deed as presented. With a majority of the court members voting aye, the motion carried and so ordered. (Deed is attached.)
- Order 7: Came on for consideration was a Resolution for the opposition to unfunded mandates.

Motion was made by Commissioner Brannon and seconded by Commissioner Benham to approve the Resolution as presented. With a majority of the court members voting aye, the motion carried and so ordered. (Resolution is attached.)

Order 8: Came on for consideration was a Resolution for the support of the County Road Grant Fund. Motion was made by Commissioner Benham and seconded by Commissioner Brannon to approve the Resolution as presented. With a majority of the court members voting aye, the motion carried and so ordered. (Resolution is attached.)

Order 9: Came on for consideration was a Resolution for the support of Local Decision Making and Opposition to Revenue Caps. Motion was made by Commissioner Morris and seconded by Commissioner Williams to approve the Resolution as presented. With a majority of the court members voting aye, the motion carried and so ordered. (Resolution is attached.)

Order 10: Came on for consideration was line item corrections and budget amendment requests. None presented.

Order 11: Public Comment
None presented.


The meeting adjourned at 9:21 a.m.

The next regular meeting is set for Monday, April 22, 2019.



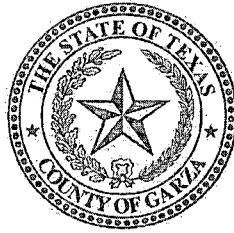
