The voter-approval rate is the highest tax rate that GARZA COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that GARZA COUNTY is not proposing to increase property taxes for the 2021 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 7, 2021 at 9:00 AM at GARZA CO. COURTROOM.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, GARZA COUNTY is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting Nancy K Wallace of GARZA COUNTY at their offices or by attending the public meeting mentioned above.
