A public hearing before the Commissioners' Court of Garza County, Texas was held on Thursday, September 19, 2019 at 9:00 a.m. at the Commissioners' Courtroom, 300 W. Main St., Post, Texas with the following members present: Lee Norman, Judge; Commissioners Pct. 1-Jeff Williams, Pct. 3-Ted Brannon and Pct. 4-Jerry Benham. Not present was Charles Morris, Pct. 2 Commissioner. County officials present: Jim Plummer, District and County Clerk; Ted Weems, Attorney; LuAnne Terry, Treasurer; Nancy Wallace, Tax Assessor/Collector; Gordon Terry, Justice of the Peace-1; and Angela Massey, Justice of the Peace-2. Also present: Carol Williams, Administrative Assistant. No one from the public was present.

PUBLIC HEARING (second of two), 9:00 a.m.

Judge Norman called the public hearing to order at 9:00 a.m.

Public hearing on the 2019-2020 proposed budget.

Judge Norman announced that the effective tax rate is .6141, the rollback rate is .6632 and the proposed tax rate is .6632.

The amount of the proposed balance budget is \$9,127,435.38.

Appraised property values are \$528,720,172.

The revenue expected for the general fund to be \$3,085,695.52. Other revenue is proposed to come from the county general fund reserves, \$222,908.86, and from the commissioners' precincts reserves, \$92,000.

Judge Norman announced that the Ag Extension office has been cleaned and re-opened by new agent Danya Peterson.


The meeting adjourned at 9:12 a.m.






JEFF WILLIAMS, COMMISSIONER PCT. 1

TED BRANNON, COMMISSIONER PCT. 3



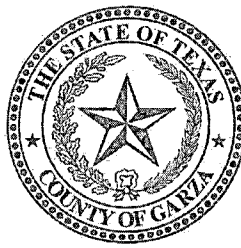
